- *Pre-alerts for road freight shipments should mention vehicle registration, driver details, copy of the customs documents (T1/T2/T-) and invoices including vessel name PO number & HS codes. to arrange customs clearance at Southampton Freight Services' warehouse.*
- *For customs purposes, please note that the customs code should be **GB000290***
- *If goods are to be cleared into our bonded warehouse, then we require pre-notification. This needs to be done prior to departure from origin. In this notification we must have routing into the UK, approx. date and time of arrival, vehicle registration and copy of the invoice so we can complete the customs process prior to the vehicle departing originating country – this will ensure that the import entry number is available so this can be added to the drivers GMR.*
